African Orphan Educational Foundation, Inc is a Florida not-for-profit corporation that promotes awareness of and supports the educational and personal development needs of orphans and impoverished youth in Africa while nurturing cultural appreciation and harmony between nations. This website seeks to: inform Users of the needs of the populations we serve, outline the services and support we provide to these communities, and facilitate donations and communication to/from those who wish to join and support our efforts.

This privacy policy outlines how we collect, use and disclose Personal Information of visitors to our website, including the other media forms, channels, mobile websites and applications that may be related to or connected to it.

Acceptance

By accessing, browsing and/or using this site, you acknowledge that you have read, understand and agree to be legally bound by our privacy policy.

Information Collected

African Orphan Educational Foundation collects personal and nonpersonal information about its Users. Personally-identifiable information such as first and last name, mailing address, phone number and e-mail address are collected from donors, board and advisory council members, subscribers, volunteers and friends who wish to stay updated on our efforts via regular communication like e-mail and newsletters. We use this information to thank donors and volunteers, forward letters of receipt to donors for tax deduction purposes, analyze and evaluate our own development efforts and maintain records as may be required by the IRS. These records are maintained in password-protected electronic files. Personally-identifiable elements and user-provided credit card information is collected by our payment processor for purposes of facilitating your credit card transactions. African Orphan Educational Foundation does not collect or store any credit card information from donors. Nonpersonal information collected includes internet protocol (IP) addresses and browsing variables (web browser, referral links, time spent on website). The latter information is used to improve your experience and the experience of other visitors to our website.

Cookies

Cookies are files with small amounts of data commonly used as anonymous unique identifiers. These are sent to your browser from the websites you visit and are stored on your computer's hard drive. Our website may use cookies to collect information.

Service Providers

We employ third-party providers who perform services for us by facilitating service to you. African Orphan Educational Foundation's privacy policy does not cover information you relay directly to third-party providers. Security Policy

Your trust in us is important, so we have put in place physical, electronic and managerial procedures to safeguard your information. Records containing your personal information are stored in secured files and at secure facilities; our SSL website uses encryption to protect all parties. Our payment processor Get Beyond uses PCI compliant encryption and tokenization to secure transaction and credit card data.
